**Proposed Development:**

The erection of a 5 storey mixed use development in 4 blocks over basement car parking, with recessed penthouse level and roof gardens, to consist of 3 no. commercial units and a public house/cafe-bar on the ground floor, 55 apartments (comprising 6 no. 1 bedroom, 36 no. 2 bedroom and 13 no. 3 bedroom units) and associated site works.

Significant further information has been furnished in relation to alterations to a mixed use development to consist of; (a) the removal of a Block of apartments to the southwest of the subject site and relocation of these by means of an additional floor of apartments along the Old Ballymun Road thus providing 63 apartments (8 one bed, 43 two bed and 12 three bed) in 3 blocks and (b) a reduction in ground floor commercial area providing 3 commercial units and a public house/cafe-bar.
