Description;

Dublin City Council hereby gives notice of their intention to carry out works to the road network at Balcurris in Ballymun, Dublin 11. Works to be carried out consist of a revised access to Balcurris Gardens and Balcurris Road, which will be realigned and upgraded under a previously approved Part 8, (Reg Ref 5376/08). The new access will comprise a 2-lane carriageway of 6m in an east/west direction from Balcurris Road, (to be realigned), to connect a new north/south local road of 4.8-6m, giving access to Balcurris Close and Balcurris Gardens, with associated footpaths and landscaping.

The plans and particulars of the proposed development will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy for a period of six weeks from 29th July 2010 during public hours at the offices of Dublin City Council, Civic Offices, Wood Quay, Dublin 8. The plans and particulars of the proposed development will be available for inspection only during public opening hours at the Ballymun Civic Centre, Main Street, Ballymun, Dublin 9.

A submission or observation in relation to the proposed development, dealing with the proper planning and sustainable development of the area may be made in writing to the Executive Manager, Planning Department, Dublin City Council, Civic Offices, Wood Quay, Dublin 8, before 16.30hrs on 22nd September 2010.
