F08A/0161]. The proposed development will comprise the increase in floorspace from c. 850 sq.m. to c. 1,147 sq.m. with the introduction of a mezzanine level (of approx 297 sq.m.) within the existing building and overlooking existing permitted ground floor level. No change to the external appearance of Unit C8 is proposed.
