Dublin City Council hereby gives notice of their intention to carry out works to the road network at Poppintree in Ballymun, Dublin 11.

Works to be carried out consist of modifications to the road network at Balbutcher Lane North and South, Poppintree Park Lane West and Hampton Woods Access Road. Modifications involve the realignment of Balbutcher Lane North and South, Poppintree Park Lane West, the internal access road at Hampton Woods and the replacement of the existing roundabout with a signalised junction. The realigned roads and junction will connect with the Hampton Woods development to create a new road connection to the R104, St. Margaret's Road, as previously permitted in Reg. Ref. 4387/03. Footpaths and cycle provision will be included in the works.

The plans and particulars of the proposed development will be available for inspection or purchase at a fee not exceeding the reasonable cost of making a copy for a period of six weeks from 5th November 2010 during public opening hours at the offices of Dublin City Council, Civic Offices, Wood Quay, Dublin 8. The plans and particulars of the proposed development will be available for inspection only during public opening hours at the Ballymun Civic Centre, Main Street, Ballymun, Dublin 9.

A submission or observation in relation to the proposed development, dealing with the proper planning and sustainable development of the area may be made in writing to the Executive Manager, Planning Department, Dublin City Council, Civic Offices, Wood Quay, Dublin 8, before 16.30hrs on January 2011.
